**NOTICE OF RACE**

**1. RULES**

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing* (RRS).
- 1.2. For the purposes of the definition of *rule*, the class rules shall be the rules of the J/70 will apply.
- 1.3 The following rules will be changed: rule 44.1 and A2. These changes will also appear in full in the Sailing Instructions. Additional rules may also be changed in the Sailing Instructions.

**2. ELIGIBILITY & ENTRY**

**2.1 Sailor Classification**

All competitors will be classified as a Cat 1 or Corinthian sailors

**2.2 CLASS ASSOCIATION MEMBERSHIP**

US Sailing recommends that competitors are members of their respective class associations (J/70).

- 2.3 Each competitor will be responsible for their boats being in compliance with the class rules.

**3. FEES**

The entry fee for all classes is \$**100.00** per boat. The entry fee includes ***Lunch and Drink During the Event.***

**4. SCHEDULE OF EVENTS**

11am on May 20<sup>th</sup> will be Skippers Meeting

First Flight of Sailors Start at 12:00pm  
Last Flight of Sailors End at 4:00 pm  
Awards for Stadium Sailing at 4:30 pm

5. **ADVANCE REGISTRATION** - Competitors shall register in advance by registering online at GPYCSAILING.ORG. Entry deadline is day of race.
6. **SAILING INSTRUCTIONS** - The Sailing Instructions (SIs) will be available at registration and on the web at: GPYCSAILING.ORG
7. **SCORING** Nine races will be sailed per competitor and nine races will be counted.
8. **SAFETY** - A US Coast Guard approved personal flotation device shall be worn, properly fastened, at all times while launching and when sailing, except briefly when adding or removing clothing.
9. **MEDIA RIGHTS** - By participating in this regatta, a competitor (or parent/guardian if under age 18) grants to the PSL and their sponsors the right in perpetuity to make, use and show, from time to time at their discretion, any photographs, motion pictures and live, taped or filmed television and other reproductions of him or her during the period of the competition without compensation.
10. **VENUE** – The sailing will be in front of the East Wall at the Grosse Pointe Yacht Club.
11. **Courses**-Windward leeward four legs gates at mark 2
12. **Penalties**-If you hear a whistle followed by your bow number you are required to make a 360 degree turn that includes a gybe and tack.
13. **On Water Communication**-Loud Hailer (On Land Speakers at sail center)
